

**OTISCO TOWNSHIP SPECIAL MEETING**

**February 21, 2013 @ 6:00 PM**

THE MEETING WAS CALLED TO ORDER BY CLERK, LYNDA SOWER AT 6:20PM.

MEMBERS PRESENT: CLERK, LYNDA SOWER – TREASURER , JANET BREIMAYER,  
TRUSTEE, DAN ZEIGLER

MEMBERS ABSENT: SUPERVISOR, PAUL REEVES – TRUSTEE, BEN OATLEY

THERE WAS A DISCUSSION ABOUT THE DAMAGE THAT WAS DONE ON FEBRUARY 14, 2013. WHEN A TRANSFORMER AT THE DOUBLE R RANCH CAUGHT FIRE AND BURNED ON THE POLE – FELL AND WIRES WERE DAMAGED. WE HAD A POWER SURGE, AND THE NEXT DAY THE SERVER COMPUTER, WHICH IS THE CLERK'S, DID NOT ALLOW ANYONE TO BRING UP WORK ON THEIR COMPUTERS FROM BS&A. WE CALLED IN OUR NEW IT PEOPLE FROM ADDORIO.
