- \*On Belding Rd. there is a property owner who would like to turn the barn into a wedding venue.
- \*The property on Flat River Trail; a 3 acre pond is planned for that property.

The Board has a road agreement to take action on. Breimayer moved that we approve the quote of \$33,033 for the limestone on Montcalm Rd. and Sower supported. 5-0 Approved Reeves presented the agreement for a culvert on Palmer Rd. Reeves moved that we approve the culvert for \$5460 on Palmer Rd. and Breimayer supported. 5-0 approved
